Semester 1:

- Submit a Monthly Report by the last day of each month
- Submit project proposal (optional)

Semester 2: Participation in semester 2 dependent on project proposal approval.

- Launch Fellowship project
- Submit a Fellowship Reflection before the Project Showcase
- Present at the Project Showcase

DESCRIPTION

Education Justice Fellows will work with NEA-NM, local union affiliate leadership, the New Mexico Statewide Network for Community Schools, community leaders, decisionmakers, local organizers, and educators to develop and act upon grassroots strategies for advancing education justice in the state during a year-long fellowship program.

Fellows will come from across the state, work in varied roles in their schools, and have differing levels of experience with organizing and advocacy. Throughout the fellowship year, fellows will learn about social/racial justice, develop their leadership and organizing skills, meet regularly with local affiliate leadership, and develop and carry out education justice projects.

OBJECTIVES

- 1. To foster the creation of a cohort of fellows well-versed in social and racial justice in education through engaging learning opportunities and experiences, including discussions with community activists and grassroots organizers, study and discussion of public policy, and direct engagement with students and community members.
- 2. To develop fellows' leadership skills and community and union organizing skills by providing opportunities to meet with local union affiliate leadership, receive peer mentoring and one-on-one coaching from experienced organizers, and get comfortable with the process of grassroots organizing.
- 3. To provide fellows with a supportive "incubator" environment in which to develop and carry out, in collaboration with their local union affiliate, an education justice project with a real, demonstrable impact on an issue of importance to their local affiliate and community.

DESCRIPTION

Since its founding as the Territorial Education Association in 1886, the National Education Association – New Mexico (NEA-NM) has continuously advocated for New Mexico Public Schools and their students and employees.

With more than 8,000 members in local affiliates across the state, the Association works for better learning conditions for children and better working conditions for teachers and other school employees. Local affiliates work for members through collective bargaining and other advocacy mechanisms in communities throughout New Mexico, while NEA-NM works to influence policy makers at the state level.

Additionally, the Association provides professional development for its members, including opportunities like the Education Justice Fellowship.

UNION STRUCTURE

Three Level Structure - Local, State, and National NEA's three-level unified structure, which includes local and state affiliates as well as the national-level organization, makes it possible to ensure every educator, in every city, in every state, has the power to create great public schools.

Committed to Democracy

NEA-NM members state-wide set Association policy, most notably through the annual Delegate Council, held in the Fall each year. Delegates are elected from local associations in the ratio of one delegate for each 25 local members. During the rest of the year, the NEA-NM Board of Directors, elected from regions around the state, sets policy along with the full-time elected President.

NEA-NM members are also regularly surveyed to assess educators' opinions on critical topics, the results of which are translated into NEA-NM's yearly Legislative Goals and reports used to advocate for better working conditions and a more just and equitable public school system.

BOOKS

Teacher Unions and Social Justice

Throughout the Fellowship year, Fellows will be asked to read sections of the book <u>Teacher Unions</u> and <u>Social Justice:</u>
Organizing for the Schools and <u>Communities</u> Our <u>Students</u>
Deserve. Fellows will be asked to make connections between the book, the Fellowship, and the work of NEA-NM and their local union affiliate and be prepared to discuss with the rest of the cohort.

PLATFORMS

NEA edCommunities

This is a social style platform where Fellows can connect with one another and share their thoughts and experiences with the Planning Team. Non-Urgent updates will be shared with Fellows via the NEA-NM ED Justice Cohort group.

NEA PEP - LearnUpon

The Professional Excellence Portal is a platform where fellows can sign up for professional development courses with instructors from the National Educators Association network.

GENERAL STRUCTURE

Summer Leaders Meeting

This fellowship cohort will kick-off with a summer retreat in Albuquerque, NM from June 15-June 17. Here, Fellows will be introduced to the program structure, meet and begin engaging with local affiliate leaders, and participate in engaging workshops and discussions.

Two Six-Month Semesters

The first six-month semester will prioritize learning about social and racial justice issues, building leadership skills, making connections, and beginning development of fellows' education justice projects.

Following the approval of fellows' project proposals, in the second six-month semester fellows will focus on the implementation of education justice projects supported by group meetings and discussions with local affiliate leaders and peers.

Twice Monthly Meetings

The Fellowship cohort will meet on the first and third Wednesday of each month, except for where not possible due to holidays. The second meeting of each month will include time for fellows to engage with local affiliate leadership and local peers.

FXCFILENCE

NEA-NM's Education Justice Fellowship is first and foremost a working fellowship. Fellows will receive a \$1500 stipend per semester upon completion and receipt of all requested deliverables, including all monthly reports and project proposals/reflections.

All Fellows will receive regular check-ins from Fellowship mentors. Fellows must submit and have their project proposals approved at the end of the first semester to participate in the second semester. This is to ensure all Fellows have carried out the necessary preparatory work and are committed to excellence in carrying out their project.




